

Regulations for access to Guests in the Colleges as of January 10, 2022

The application of the rules established by the Fondazione Collegio Universitario S. Caterina da Siena with the Security Protocol and the Vademecum, as well as, obviously and even more so, the various levels of discipline adopted and to be adopted with regard to containing and combating the Covid-19 emergency.

We firmly recommend to all students and workers the need for continuous updating of the above discipline, an update to which the Fondazione Collegio Universitario S. Caterina da Siena will cooperate with the Rectorates of the Colleges.

We firmly believe that the serenity of collegiate life requires the conscious and responsible adherence of all - students and staff - to those behavioral precautions that ensure adequate levels of protection **(green pass, temperature control, physical distance and use of masks)**.

Considering the national and regional measures regarding the attribution of epidemiological scenarios and the consequent measures that will be adopted from time to time by the competent authorities regarding the location of the territorial area in which each College is located.

Considering the national measures related to the use of COVID-19 green certifications of vaccination or cure.

With regard to access to the Colleges of the St. Catherine of Siena University College Foundation by Guests invited by the / of the Colleges, the following is provided.

Art.1 RED ZONE

1.1. In the case of classification of the territorial area in which the College/Residence is located as a red zone, access by Guests is prohibited.

Art. 2 ORANGE ZONE

2.1. In the case of classification of the area in which the College/Residence is located as an orange zone, guests may be admitted to the structures if they have a green certificate or are exempt from compulsory vaccination under the conditions indicated in Art. 2.2 and Art. 2.3.

2.2. Conditions for access to structures:

- i)** Absence or otherwise number of no more than 3 'active' covid 19 cases in College or Residence Hall.
- ii)** Written request before access to the Rector of the College and subsequent authorization by the Rector of the College.
- iii)** Access can only be authorized during hours when the Reception is open.
- iv)** Access limitation for each Structure. Maximum numerical limit of 10% of those present (max 7 guests for the College and max 4 guests for the Residence).
- v)** Recording of name and identity data, including cell phone number on the Guest Register and signing by the Guest of the documentation attached to the Safety Protocol: i) statement all. 1 (virtual swab); ii) statement of commitment to comply with all the conditions of internal health care at the College, with particular reference to the use of masks model FFP2; iii) statement of exoneration of liability in favor of the administration of the College; iv) statement of commitment to notify the College in case of positivity in the 7 days following the visit.
- vi)** Verification of possession of enhanced green pass and body temperature upon entry.

i) Identification of spaces (rooms/common areas) to which Guests may have access and related

authorization/restriction mechanisms.

Art. 3 **WHITE ZONE** **YELLOW ZONE**

3.1 In the event that the area in which the College is located is classified as a white zone or a yellow zone, guests may be admitted to the Colleges if they have a green certification or are exempt from the vaccination requirement under the conditions indicated in Art. 3.2. and Art. 3.3.

3.2 Conditions for access to the Colleges:

- i) Absence or otherwise no more than 3 'active' covid 19 cases in the Facility.
- ii) Access of **1 guest per Collegiate**, unless otherwise authorized by the Rector following a justified written request.
- iii) Access can be authorized only in hours when the Reception is open.
- iv) Registration of the name and identity data, including cell phone number on the Guest Register and signing by the Guest of the documentation attached to the Safety Protocol: i) statement all. 1 (virtual swab); ii) statement of commitment to comply with all the conditions of internal health care at the College, with particular reference to the use of masks model FFP2; iii) statement of exoneration of liability in favor of the administration of the College; iv) statement of commitment to notify the College/Residence in case of positivity in the 7 days following the visit.
- vi) Verification of possession of enhanced green certification and body temperature at admission.

3.3. It remains for the Rector to provide for the following:

- i) possible revision in more restrictive terms of the preceding criteria based on the specificities of the various structures, the ongoing behavior of the / of the Colleges and other reasons, with particular regard to compliance with the rules of containment of the Covid-19 emergency

(distancing and use of masks); Identification of spaces (rooms/common areas) to which Guests may have access and related authorization/restriction mechanisms.

Art. 4 Final rule

4.1. Without prejudice to the strict observance, for all that is not otherwise provided herein, of the Regulations of the collegiate communities and of the Security Protocol and the Vademecum Fondazione Collegio Universitario S. Caterina da Siena for the containment of the pandemic emergency. The provisions of these Regulations shall remain in effect as of **January 10, 2022 until revoked or reissued.**
